Send your check by mail or drop it off at the club in the renewal box near the sign-in table. Only submit the forms as email attachments if you are also including scans of your license and rabies proof with the forms.
- \* To fill out the forms electronically, open with Acrobat Reader the pdf file on your screen and click "fill and sign." When forms are filled out, save and attach to an email, along with rabies/license proof scans, to Membership@SuburbanDogTraining.com.
