### **IMPORTANT!**

- Zoning regulations require you to mail a copy of your **current rabies vaccination certificate** and **current dog license** along with this application.
- You must wear low-heeled, rubber soled shoes.
- Handlers must clean up after their dogs. Clean-up equipment is available indoors. A trash can and bags are supplied outside. Exercise area is in the vicinity of the trash can—do not let your dog use any other part of the grounds.

### **Directions**

**From Germantown Avenue:** Take E. Willow Grove Avenue approximately one mile to building set well back on left just before the firehouse.

**From Route 309:** Take Mt. Airy Exit to south on Easton Road. Turn right on Cheltenham Avenue. Turn left on E. Willow Grove Ave. (2nd traffic signal). Building is set well back on right just after the firehouse.

Building is at the back of the parking lot behind the fence. Enter through firehouse driveway and park on the gravel lot. Door is at the right end of the building.

Handling classes are limited in size and applications are accepted on a first come, first served basis.

**A limited number** of spaces are available for persons coming for a one-night class.

The Club reserves the right to refuse drop-in admittance depending on size of class.
